Veterinary conditions:

The cats must be vaccinated against feline panleucopenia, feline calicivirus and feline herpesvirus, and have had the required boosters, at least 15 days prior to the show. The period of the validity for the vaccination is marked by the veterinarian in the pet passport or on the vaccination certificate. Vaccination against rabies is to be according to national legislation – all cats living outside of the Czech Republic must be vaccinated against rabies. White cats must have a certificate stating that they are not deaf.

Show conditions:

Exhibitors may present their cats to the judges themselves; however, stewards will be at your disposal. Participation in the show is at the **exhibitor's own risk**. Cats must remain in decorated cages until the exhibition is officially closed.

Other conditions:

Confirmation: Entry confirmations will be sent by e-mail. If you do not receive a confirmation, exhibitors must check at least **5 days prior** to the show whether their cat(s) have been accepted. **Cancellations:** Refunds of registration fees are only possible for cancellations made before the official closing date. **Participation:** Without a valid confirmation and entry in the catalogue, cat(s) cannot participate in the show. **Cages:** Cages are arranged in alphabetical order by the exhibitor's last name. **Moving your cat(s) to another cage without permission will result in the nullification of your results.** **Early departure:** Leaving the show before its official end without permission will also lead to nullification of results. **Own Cages:** If you are bringing your own cage, please indicate its **size** in the note on the application form. **Classes 11, 12, 14, 15, and 16:** Kittens and juniors may be shown for a maximum of 2 consecutive weekends and must have a break during the following weekend. **Facilities:** Chairs will be available. **Free parking** is provided at the venue.
